Chief Executive's Report to the Board			

2008/09 Offshore Statistics

1. The offshore statistics for the 1 April 2008 until the 31 March 2009 (based on provisional figures for 2008/09) were published in the Offshore Safety Statistics Bulletin on the 5 August 2009 with considerable press interest and positive publicity.
2. The headline accident injury statistics were:
 - No workers were killed while working offshore in areas within HSE's field of responsibility during 2008/09 – the second consecutive year with no fatalities for the first time since HSE took responsibility for offshore safety - and there was a fall in major injuries with 30 reported, a fall of 14 compared with 2007/08 figures;
 - The combined fatal and major injury rate reduced to 106 per 100,000 workers in 2008/09, compared with 156 in 2007/08 and 146 in 2006/07; and
 - In 2008/09, there was a small fall in the minor three-day injury rate with 496 workers per 100,000 reporting an injury, a new low, improving on the broadly flat trend over the previous seven years.
3. The above rates and the number of major injuries are the lowest recorded since HSE took responsibility, in 1991, for offshore safety following the Piper Alpha disaster.
4. The number of major and significant hydrocarbon releases, regarded as potential precursors to an incident, also showed marked improvement with 61 in 2008/09 compared with 74 in 2007/08 also the lowest number on record. Only one major hydrocarbon release was reported.

Clostridium difficile deaths in Scotland

5. Calls for the expansion of the planned Public Inquiry into c-difficile related deaths at the Vale of Leven Hospital in West Dunbartonshire have been made recently following the announcement of two clusters of elevated death rates due to infection at Gartnavel Hospital in Glasgow and press reports that indicate significant increases in deaths across Scotland, either through direct causation, or as a result of contributory factors relating to infection. A decision to hold a Public Inquiry into the deaths at the Vale of Leven Hospital was made by the Scottish Government in May 2009. The terms of reference for this Inquiry have yet to be agreed.

6. The Health and Safety Executive participated in a joint investigation into the circumstances of the Vale of Leven with Strathclyde Police at the request of the Crown Office and Procurator Fiscal Service after an independent investigation by Health Protection Scotland indicated possible work related causes. Additional HSE reviews of management systems at two other hospitals for which elevated death rates due to c-difficile were identified were also carried out over the past 9 months. These hospitals were part of Fife and Grampian Health Boards.
7. The Healthcare Commission does not operate in Scotland and HSE is the only enforcing authority in place to investigate cases of Healthcare Associated Infection that result from work related factors, other than the Police who may be instructed by the Procurator Fiscal to work with HSE, under the terms of the Work Related Deaths Protocol, to investigate deaths with a view to establishing or discounting corporate homicide as a cause.

Implementation of the Artificial Optical Radiation Directive

8. Following the Board's discussion, HSE are working to develop a set of new regulations limited to the minimum required to meet the additional requirements of the Directive. These will be aimed only at those businesses that use hazardous sources of artificial optical radiation, thereby minimising unnecessary wider burdens. A detailed communications plan is being developed to ensure that businesses, and in particular SMEs fully understand what will, and importantly what will not, be required of them. Full consultation of stakeholders will take place later in the Autumn after approval of the consultation document by the Board.

Agriculture revisited initiative

9. Since the recommendations in paper HSE/09/46 were agreed by the Board in May 2009:
 - Communications Directorate launched Phase 2 of the campaign at the beginning of June. Direct mailing was targeted at those who had received but not responded to the Phase 1 mailing, supported by adverts in the trade press. Simultaneously, other public relations (PR) materials were directed to the responders from Phase 1 reminding them to 'Keep the Promise, Come Home Safe' particularly over the busy harvest period. To date there have been ~14,000 responses from Phases 1 and 2; an excellent response which compares very favourably with other Government campaigns. Phase 2 will be completed by the end of September. Phase 3 is provisionally scheduled for December 2009;
 - The Agriculture & Food Sector (the Sector) and FOD have agreed proposals for the planning, management, budgetary control and delivery of the Safety and Health Awareness Days (SHAD) and Agricultural Show programmes for 2010/11 and beyond which reflect the Board's desire for a more strategic approach;
 - Working with industry stakeholders, the Sector has progressed the 'Machinery and suppliers' and 'Vocational qualifications and education' projects which directly support the Initiative and which have links with one or more of the themes in the new strategy. Simultaneously, a consultant has been appointed and started work on the 'Stakeholder mapping' exercise requested by the Board; and

- CSAG has been working with the joint Programme Managers to develop leading indicators and an Invitation to Tender (ITT) for a suitable contractor to carry out the proposed holistic, retrospective evaluation of the Initiative.
- Judith Donovan's continued support and involvement has again been much appreciated.

Risk Assessment and Policy Template

10. A Risk Assessment and Policy Template combining the requirements of a health and safety policy, risk assessment and written record of health & safety arrangements will be ready for launch on 1 September 2009.
11. The template has been developed to help reduce the burdens on small to medium, lower risk enterprises. It has been designed to be used along with the example risk assessments, and furthermore an example health and safety policy which is provided as a guide to illustrate what is broadly required. This package is intended to demonstrate to businesses what a sensible and proportionate approach to meeting their basic health and safety duties looks like in practice.
12. These initiatives form a key strand of the simplification plan and savings will contribute towards the 25% (£505 million) target reduction of health and safety administrative burdens on businesses to be achieved by 2010.
13. The template has been approved by the Embedding Sensible Risk Management Steering Group which includes a number of key stakeholders and also by the Small Business Trade Association Forum.
14. A communications plan for internal and external stakeholders has been developed for promotion of the template and the example risk assessments.
15. An evaluation strategy has been drawn up with the Chief Scientific Adviser's Group (CSAG) to enable HSE to measure the success of the tools. The results of the evaluation will be ready for publication in the final Simplification Plan due in autumn 2010.

Civil Service People Survey (CSPS)

16. The Cabinet Office in consultation across all Departments has developed a single Employee Engagement Survey to be rolled out across the Civil Service in October 2009. The Civil Service People Survey (CSPS) seeks to enable employee engagement to be embedded as a key management resource in improving Departmental performance and Civil Servant wellbeing. It will focus on Employee Engagement replacing the more traditional staff satisfaction surveys that provided valuable insight but offered little steer for managers as to what should change to improve performance and motivation of staff.
17. The Survey was piloted in several Departments early in 2009 and following evaluation and further consultation a refined questionnaire has been agreed. We are preparing for implementation having decided to join with the "DWP family" for this exercise although the survey will remain HSE specific and enable us to analyse the information for HSE alone.

18. A staged roll out will be implemented across departments and the HSE Survey will “Go live” on 12 October for a period of 3 weeks closing on 1 November. A detailed Communication plan is being prepared to complement the launch, results and action planning stages of the exercise. The headline results should be available a few weeks after the end of the ‘Go Live’ period. Full results, including the Employee Engagement Index, Key Driver Analysis and benchmarking data should be available by 1 February 2010. We will report in due course to the Board on the outcome.

Nuclear Directorate Transition Update

19. HSE have established a transition team working within the Nuclear Directorate (ND) to plan for the delivery of the proposed transition to a statutory corporation. The team comprises ND Staff and experienced Interim Managers for HR, Finance and Programme Management supplemented by specialist advice in key areas. The transition programme focuses on the activities required to create the statutory corporation and continuing the operational improvements already underway in ND – all without detriment to current regulatory activities

20. The initial focus of the team has been on robust planning and governance for the various work streams required to deliver the transition and engagement with internal and external stakeholders. To support this a new head of communications has been appointed and new communication channels have been implemented, including a regular staff newsletter and interactive community site. In addition conferences have been arranged for all staff and for the CEO’s of licensees and duty holders and regular consultation meetings with HSE trade union representatives are taking place. This communication activity will support the programme in delivering key messages and information to all stakeholders throughout the planned activities.

21. The immediate priorities focus on the potential HR changes associated with the proposed transitions that are critical to the success of the programme. The key milestone is to have the necessary processes in place to enable shadow operation of the proposed statutory corporation by April 2010.

HWWW Update

22. Apart from those taking Voluntary Early Retirement / Severance (VER) on compulsory terms, and others who have agreed 'exit' arrangements in place (45 altogether), this leaves us with only 25 staff whose futures are still to be determined. Of these, 7 are still present in Rose Court and most of the remainder are currently out of HSE, mainly on loan to other Government Departments. HR staff working with line managers, will continue to assist all of these staff to secure future employment including liaising with Other Government Departments to turn loans into permanent arrangements where possible. The Crown Prosecution Service will take over responsibility for Rose Court from the end of September 2009.

23. The Programme team are now considering arrangements for closing the programme possibly later this year and for ensuring that the intended benefits are realised.

Operations

Fatality Details

Following a recommendation made by the Information Commissioner, HSE extended its policy to include the names of the deceased and additional details on these fatal incidents on our webpages. Accordingly, since 1 April 2009, the names of the deceased plus additional details may be viewed at:

To ensure that details are not released prior to inquest, HSE delays publication until at least one month from the date of notification to HSE has elapsed. Occasionally owing to a period of latency between an accident being reported and the death of the injured person, details of incidents that occurred prior to the current reporting period may be included in the statistics.

Since the last update to the HSE Board, 22 fatal accidents reported to HSE under RIDDOR were published to HSE's website, please see Annex 2 for details.

Significant Prosecutions for July 2009

- [An Essex builder](#) and contractor were jailed for three years and for 15 months respectively when a 15-year old labourer was crushed and killed by a wall that he had been told to demolish.
- [A Powys gas fitter](#) was jailed for three years for causing two deaths by carrying out sub-standard gas work on an appliance for which he was not qualified to do so and for undertaking that work without Gas Safe registration.
- [A Cheshire metallurgical testing company](#) was fined £533,000 plus £200,000 costs when two employees were asphyxiated in a confined space.
- [A London-based firm of contractors](#) was fined £150,000 plus £25,203 costs when one worker was fatally struck and another seriously injured by an improperly secured platform being lifted by a crane.
- [A Hampshire waste handling company](#) was fined £60,000 plus £29,061 costs when an employee was struck by a vehicle and subsequently died of his injuries.
- [A Merseyside firm of contractors](#) was fined £25,000 plus £14,086 costs when a roofer fell from height and was fatally injured.
- [A Warwickshire gas fitter](#) was fined £5,000 plus £20,632 costs for failing to comply with an Improvement Notice requiring him to either register with Gas Safe or cease trading.
- [A Birmingham waste handling company](#) and West Yorkshire engineering company were fined £100,000 plus £22,000 costs and £70,000 and £22,000 costs respectively when an employee fell from height and sustained serious injuries.
- [A Lancashire meat processing company](#) was fined £25,000 plus £20,000 when two employees contracted Legionnaire's disease as a result of the company failing to carry out checks on hot and cold water systems.
- [A Lancashire chemical company](#) was fined £50,000 plus £6,141 costs when an employee had three fingers amputated whilst working on machinery which was unguarded and for which he also had received no training.

In-year work-related deaths reported to HSE

The following table is an extract of all 2009/10 work-related deaths notified to HSE since the last update to the Board on 22 July 2009. It is taken from the latest "Names and details of fatalities" update published on HSE's website on 10 August 2009.

HSE's internet publication is the collated picture of 'as reported' information on fatalities. It does not purport to be a formal statistical release. Subsequent investigation may determine that some are not reportable under RIDDOR, for example deaths due to natural causes. Other deaths shown here may have been caused by gas incidents in the home. In such cases these deaths will not be counted in our statistics for workplace fatal injuries. Provisional quarterly figures for workplace fatal injuries are available from our latest quarterly injury figures and validated figures and information will only be available on publication of the annual fatality statistics for Great Britain.

We will verify its accuracy (e.g. the name and age of the deceased) when the incident is investigated and as more information becomes available. Although we may have done some validation of the notifier's information prior to publication on HSE's web pages we cannot guarantee the accuracy of all of the above details.

All possible work-related fatalities are separately notified to the Coroner and the Coroners Court release the name of the deceased when they open the inquest. To ensure that this release has taken place, we do not publish this information until at least a month after the date of the reported incident.

UNDER NEGOTIATION:**Proposed EC Regulation concerning the placing on the market and use of biocidal products (replacing Directive 98/8/EC)****Current status (NEW DEVELOPMENTS):**

The European Commission (EC) has published a formal legislative proposal for a major review of the Biocidal Products Directive. This proposes that an EC Regulation, which will be directly applicable in Member States, will revise and replace the current Directive. The proposal identifies five policy areas for change: scope, product authorisation, data sharing, data requirements and fees. The Swedish Presidency is keen to make progress, with negotiations having started. **HSE is currently consulting stakeholders to inform the UK's position on the proposal.**

Proposed Directive on 3rd List of Indicative Occupational Exposure Limit Values (IOELVs)

Current status (**UNCHANGED FROM LAST BOARD UPDATE**):

A Technical Progress Committee meeting of Member States took place on 31 March 2009. The meeting was inconclusive because of differences of opinion concerning one substance, with no vote taken. The EC has since withdrawn the substance with concerns against it from the annex of the draft directive pending consideration of the results of an on-going study. Following a further vote, the European Parliament will subject the dossier to scrutiny, before adoption by the EC towards the end of 2009. Member States will then have 2 years in which to implement the Directive.

Proposed EC Regulation to replace Directive 91/414/EEC the on authorisation and marketing of pesticides

In January 2009, the European Parliament agreed a new Regulation to replace Directive 91/414/EEC, which establishes a framework for the authorisation and marketing of plant protection products in the European Union. It follows a second reading agreement reached with the Council in December 2008. The Regulation includes provisions to increase the level of protection given to human health, animal welfare and the environment. It also aims to speed up decision-making and provide clearer rules for the crop protection industry. We anticipate that the Council to endorse the agreement in September/October.

Proposed Directive on the sustainable use of pesticides

Current status ([UNCHANGED FROM LAST BOARD UPDATE](#)):

In January 2009, the European Parliament agreed a new Directive on the sustainable use of pesticides, which establishes a framework for greater harmonisation of controls on the use of plant protection products in the European Union. It follows a second reading agreement reached with the Council in December 2008. The Directive requires Member States to develop national action plans to reduce the risk associated with the use of pesticides and dependency on these chemicals. The Directive goes on to list a number of measures that will populate the plans. These include provisions relating to: training of users, distributors and advisors; controls on sales; testing of application equipment; protection of watercourses, amenity and conservation areas; handling and storage; and use of integrated pest management approaches. We anticipate that the Council will endorse the agreement in September/October.

Proposed EC Regulation on pesticide statistics

EC Regulation on Classification, Labelling and Packaging of Substances and Mixtures (1272/2008) – 1st Adaptation to Technical Progress

Current status (UNCHANGED FROM LAST BOARD UPDATE):

Member States agreed the 1st Adaptation to Technical Progress (ATP) of European Commission's (EC) Regulation on Classification, Labelling and Packaging on 25 March 2009 - this comprises both the 30th and 31st ATPs to the Dangerous Substances Directive. However, in December 2008, ETIME SA, a Turkish borate producer, issued proceedings against DWP seeking Judicial Review and referral from a British Court to the European Court of Justice (ECJ), challenging the classifications for borate substances that appear in the 30th ATP. This followed similar action initiated by the nickel industry against DWP in September 2008, seeking Judicial Review of the classification of certain nickel compounds also in the 30th ATP, and referral to the ECJ. On 6 May, Rio Tinto joined the action initiated by ETIME. Rio Tinto is opposed to the re-classification of borate substances.

EC Regulation on Registration, Evaluation, Authorisation and Restriction of Chemical substances (REACH) (1907/2006)

Current status (**NEW DEVELOPMENTS**):

The Regulation came into force on 1 June 2007. At European Union level, the UK is working with other Member States, the European Commission and key stakeholders in a number of committees and other groups to complete the REACH framework and establish the working principles for the Regulation. Key recent developments include:

- HSE and TSoL are working closely with DEFRA to resolve unintended consequences from the move to REACH on the control of waste specifically containing asbestos. While such imports are fully controlled as generic hazardous waste, specific provisions relating to asbestos have in the past been maintained by HSE and we aim to continue this.
- HSE has been undertaking enforcement of REACH registration provisions for several months now, including issuing several notices of enforcement action against companies who have failed to 'pre-register' and so do not benefit from extended registration deadlines. This work is principally reactive, but is also the subject of an enforcement strategy that Chemicals Regulation Directorate is drawing up with the assistance of policy colleagues and counterparts from other REACH enforcing agencies in order to apply the HSE Enforcement Policy Statement to our REACH enforcement duties.

EC Regulation on Accreditation and Market Surveillance (RAMS) (765/2008)**Current status (UNCHANGED FROM LAST BOARD UPDATE):**

The Regulation sets accreditation and market surveillance obligations relating to the marketing of products in the European Union. It applies from 1 January 2010. Following agreement between HSE and the Department for Business, Innovation and Skills (BIS) on existing gaps in enforcement powers in UK legislation to meet the requirements of RAMS, BIS wrote to HSE asking if it should introduce legislation to give us and other authorities these powers. They also asked HSE if the Placing on the Market and Supervision of Transfers of Explosives Regulations (POMSTER) 1993 should be included in the list of applicable legislation. The SMT has agreed that POMSTER be included as relevant legislation.

EC Regulation on Mutual Recognition of Goods in the European Union (764/2008)**Current status (UNCHANGED FROM LAST BOARD UPDATE):**

The Regulation defines the rights and obligations of, on the one hand, competent authorities and, on the other, enterprises wishing to sell in a Member State products lawfully marketed in another Member State, when competent authorities intend to take restrictive measures concerning a product in accordance with national technical rules. It applied from 13 May 2009. We do not expect the Regulation to affect significantly HSE's activities as the majority of work products already come under specific supply directives, but the full effects will take some time to become evident.
