OPERATION SAFE HAVEN

Issue

1 At the last AIAC meeting in November 2011 a brief oral presentation was given regarding Operation Safe Haven. Members requested further information about the enforcement notices issued during the operation. This paper provides further information about the enforcement notices issued during Operation Safe Haven.

Background

- 2. The main aim of Operation Safe Haven was to ensure that the health, safety and wellbeing of migrant/vulnerable workers were being addressed.
- 3. Operation Safe Haven was a co-ordinated multi-agency initiative led by Lincolnshire Fire & Rescue Service with GLA; housing departments in Boston and Spalding District Councils; HSE; Gas Safe and Lincolnshire Police.
- 4. Visits for Operational Safe Haven took place over a two week period.
- Week 1 Monday 12th & Tuesday 13th September and
- Week 2 Monday 19th, Tuesday 20th and the morning of Wednesday 21st September

ENFORCEMENT ACTION TAKEN BY HSE

HSE issued a total of 46 enforcement notices citing 118 breaches of legislation. (See below)

ENFORCEMENT ACTION BY OTHER AGENCIES

Lincolnshire Fire & Rescue

- 1 Prohibition Notice served on overcrowding and sleeping arrangements
- 17 Home Fire Safety Check (HFSC) Referrals

Boston Borough Council

• Two prohibition notices under the Housing Act

Gas Safe

- 6 notices where the appliance was 'AT RISK'
- 3 warning notices issued on 'Immediate Dangerous' situations
- 57 appliances where not to 'Current Standards'

• made one arrest for a warrant issued by another police force

Description of notices issued during operational safe haven

- 1. Management arrangements for welfare: failure to provide adequate supply of drinking water.
 - Failure to supply suitable and sufficient sanitary conveniences including washing facilities or wholesome drinking water
 - Provision of welfare and washing facilities for workers engaged in field work
- 2. Provision and arrangements for first aid: not providing access to a suitable trained persons and equipment for first-aid.
- 3. Not providing suitable personal protective equipment to employees cutting field crops/working in fields.
- 4. Not having a system for selecting and supplying the most appropriate knife for employees cutting field crops.
- 5. Failure to provide safe storage facilities for hand knives
- 6. Arrangements to reflect the risk arising from knife use requiring provision of knives (work equipment) to their employees by the labour user are without points where no point is necessary
- 7. Failure to provide safe means of access to working platforms on broccoli harvesting rigs.
- 8. Access is possible to dangerous parts of module transplanter.
- 9. Using tractor mounted harvesting rig unmanned without appropriate controls accessible form outside the cab
- 10. Riding on tractor steps whilst the vehicle is in motion.
- 11. Prevent use of flat bed trailer as transport for passengers
- 12. Served for use by drivers of mobile phones on moving work equipment, including fork lift trucks, tractors and four-wheel drive vehicles, whilst manoeuvring in the factory yard. There was a significant risk of contact with other mobile work equipment and pedestrians.
- 13. Failure to provide a system in the workplace such that pedestrians and vehicles can circulate in a safe manner.
- 14. Defective scissor lift
- 15. Damaged windscreen on loader
- 16. Bulk LPG tank not protected against inadvertent vehicular impact with the risk of fire or explosion.
- 17. Underground metallic pipework of unknown condition delivery LPG to the heating system.
- 18. Lack of landlords gas safety certificate at Farm and associated bungalow for LPG cookers used by agency workers
- 19. Disposal of plant protection products no longer approved for storage or use
- 20. Noise control/provision of hearing provision and agency workers not wearing hearing protection
- 21. Noise assessment and no health surveillance for employees exposed above the second action level
