## **1.0 CHAIRMAN'S INTRODUCTION**

- 1.1 The Chairman thanked AMICUS for hosting the meeting and introduced a new member to PIAC, Stuart Eaves who replaces Dick Barker representing AMICUS on the Committee. Philip Doe has resigned from the Committee, as he no longer works within the printing industry.
- 1.2 The Chairman agreed to write to Mr Doe thanking him for his contribution to PIAC.

## **3.0 MINUTES OF LAST MEETING AND MATTERS ARISING**

The minutes from Meeting 81 were agreed.

- 3.1 **(Min 1.2) The Chairman** to write to Mr Barker thanking him for the work he has done on PIAC. Done – item discharged.
- 3.2 **(Min 3.3) Mr Hudspith** to consult with Amicus colleagues on how well the construction workers passport scheme works. A general discussion took place on the merits of passport schemes and whether they would work in the printing industry. Mr Hobson said BPIF had looked at passport schemes in the past but had never taken the idea further. BPIF do have a 'New Starter Induction Checklist' that is available on their web site and he said BPIF are exploring the possibility of whether it can offer additional advice to employers for inducting temporary, agency and migrant workers. Done – item discharged.
- 3.3 **(Min 3.5) Mr Hobson** to e-mail the link for the new dermatitis leaflet to members when it goes live on the website. Done – item discharged.
- 3.4 **(Min 4.2) Mr Adams** agreed to feed back to members, statistics on Item discharged.

**3.5 (Min 6.1) Members** to feed back any comments to Ms Cheetham on the Health & Safety Health Check presentation before it goes 'live' on the website. Done – item discharged.

**3.6 (Min 5.1) Mr Hobson** to send members a link to the two new glove research reports now on the website. Done – item discharged.

**3.7 (Min 5.2) Mr Hobson** to send members the updated COSHH Essential sheets when available. Done. It was pointed out that one picture on the website is inaccurate. Mr Hudspith to forward the correct picture to Mr Hobson for action.

**3.8 (Min 8.1) Members** agreed to send Mr Hobson details of their activities to include them in the PIAC annual report. Done – item discharged.

#### **4.0 Health & Safety Progress Report – Ian Hobson**

**4.1** The report is now available on the HSE Printing website. The statistics show a reduction of 23% of RIDDOR reportable accidents in the past five years.

**4.2** Mr Hobson summarized a Local HSE Printing Inspection Initiative in the Yorkshire regional local printing initiative running in October 07 and would feed back to members the results of the initiative at the next PIAC meeting.

## **5.0 MSD's**

### **European Health & Safety Week – 22<sup>nd</sup> – 26<sup>th</sup> October 2007**

5.1 This year's topic is MSD's. Members had been sent Euro H & S Week packs and more were distributed at the meeting. Mr Hudspith praised the MAC Tool and how easy it is to use. AMICUS representatives have been trained on how to use it and they will promote the use of the MAC Tool during European Health & Safety Week. Other PIAC Members agreed to let Mr Hobson know if they were holding any events during the European H & S Week.

### **5.2 WRULD's Assessment of Repetitive Tasks [ART] Tool**

Mr Hobson spoke about the new WRULD's [Risk] Assessment of Repetitive Tasks (ART) Tool which is under development by HSL/HSE. It is similar to the MAC Tool. Mr Hobson agreed to provide more details once they became available.

### **5.3 HSE's WRULD's Campaign February 2008**

HSE intends to run a WRULD campaign in February 2008. He also explained how print finishing and packaging activities would be one of the areas targeted by HSE inspectors during the inspection phase of the campaign. It is anticipated that Inspectors will be using the new 'ART' Tool as part of the process. PIAC members may want to support the HSE campaign by devising their own supporting initiatives. Mr Hobson to provide more details once they become available.

## **6.0 Slips & Trips**

### **New Mapping Tool**

### **6.1 HSE Slips and Trips Campaign 2008**

HSE are to carry out a Slips and Trips Campaign with Topic based Inspections in March and April 2008. There will be three main target areas - Education, Catering, and Contract Cleaning. Whilst Printing does not figure highly in any of the actual campaigns, the HSE slips and trips topic based inspections will continue throughout 2007/2008. Again, PIAC members may want to support the HSE campaign by devising their own supporting initiatives. Mr Hobson to provide more details once they become available.

Mr Hobson agreed to investigate and report back to members whether 'out of hours' inspections would be carried out to coincide with shift work

during the slips & trips campaign.

## **7.0 Machinery Safety – Mr Hobson**

### **7.1**

#### **Hand Fed Platens**

A fatal accident has recently occurred on a hand fed platen. HSE have issued a safety alert to the industry through the Corrugated Packaging Industries (CPI) and BPIF. HSE cannot comment further on the matter as the accident is still being investigated. The Chairman outlined some of the legal considerations involving disclosure of information where this is the case.

### **7.2**

#### **Folder Gluers**

The CPI have produced a guidance document on multi-point gluers which can be downloaded from CPI's website. Mr Hobson is to visit a Field Group site to look at these machines and will report back at the next meeting of PIAC.

## **8.0 Workplace Transport – Mr Hobson**

An update on curtain sided lorry research was given. Members agreed to send their comments and good practice solutions to Mr Hobson.

### **9.0**

#### **Open Meeting Update – Mrs Drammeh**

The PIAC Open Meeting to be held on Thursday 8<sup>th</sup> November at the Castle Grange Hotel in Kendal, Cumbria. Invitations have been sent to around 60 local companies. With PIAC members help in further promoting the event, it should be possible to reach the target of 80 attendees. Mrs Drammeh agreed to send an update on progress w/c 1<sup>st</sup> October to members.

### **10.0**

#### **Review of MDHS48 – Mr Hobson**

This document sets out a protocol for measurement of total particulates and cyclohexane soluble material in air in newspaper print rooms, commonly known as 'ink fly'. It is now due for review. Mr Hobson is to meet with Dave Blanchard from the British Coatings Federation to discuss this document - it would be useful if members could provide their thoughts / observations on the document and an indication of how much of a issue ink fly remains given technical / process changes in the industry in recent years.

Mr Hobson agreed to update members of any progress at the next PIAC meeting.

### **11.0**

#### **Migrant Workers Update – Mr Hobson**

HSE has now produced a substantial amount of information about migrant workers. Mr Hobson agreed to capture the material relevant to the printing industry on this topic and distribute it to PIAC members.

## **12.0 Miscellaneous Business**

### **12.1 HSC/HSE Merger**

The chair of HSC, Sir Bill Callaghan retires in October 2007 and will be replaced by Judith Hackitt. The proposed merger of the Commission and the Executive may have repercussions for IAC committees in the future i.e. if HSC no longer exists, the underlying rationale for IACs may need to be reviewed. He promised to keep the Committee informed.

### **12.2 ECJ Ruling – ‘So Far As Reasonably Practicable’**

The Chairman updated the Committee on this important case. The European Court of Justice has rejected the European Commission's claim that the use of "so far as is reasonably practicable" does not fully implement the Framework Directive.
