

## **PABIAC Nov 2007 – Papermaking Sector/ CPI Update**

### **1) Injury statistics**

The most recent accidents statistics are as follows:-

Latest figures from the papermaking sector show an overall improvement in the total number of accidents being reported. The overall injury rate now stands at **9.82** (x 1000 employees).

The major injury rate remains at **0.68** (x 1000 employees).

### **2) Senior Management Symposium**

CPI held its Senior Management Symposium on 10<sup>th</sup> October, at the Institute of Directors in Pall Mall, London.

The day long event was held exclusively for Senior Management from across CPI's membership and covered a number of issue related topics.

Organised as a replacement for the "old" Chief Executives Health and Safety Day, it was appropriate that the first 2 presentations related to health and safety issues.

Graham King, HSE gave a progress report on the PABIAC strategy 'Making a Difference' and the latest injury statistics, before issuing a challenge to aim for an improvement in accident performance that would put them better than the manufacturing average and set them well on the way to achieving world class standard when compared with any manufacturing industry worldwide.

Dr Sayeed Khan, HSC gave a thought provoking presentation on Occupational Health and the benefits of having an active rehabilitation programme.

Both presentations were very well received

### **3) Health and Safety Committee meetings**

#### **Paper & Tissue H&S Committee**

The group met in July. The main agenda items for discussion and action were the sector action plan 2008 – 2009 along with the PABIAC strategic targets proposal for 2008 – 2011.

Topics for possible inclusion in the action plan included

- Holding a regional event with a common theme
- Occupational Health
- Transport
- Safety management and pro-active measures
- Felt changing
- Machinery accidents ( ref biennial conference)
- Supporting the targets in the PABIAC objectives 08-11

These will all now be considered further in terms of SMART deliverable outcomes

### **4) CPI web updates**

#### **The Safe Purchase and Installation of Machinery, Plant & Equipment**

In recent years a significant number of new or recently purchased pieces of equipment have been found not to be guarded to the required UK standards or being operated by unsafe methods. The

consequences of such purchases have included expensive retrofitting or rectification, delays in commissioning and at worst accidents. This guidance document, produced by members of the Corrugated Health and Safety Committee is applicable to all sectors, and is designed to assist companies in planning and implementing the purchase of new machinery, plant and equipment. To support the general principles contained within the document there are a number of checklists designed to assist in the process.

### **Safety Alerts**

#### **Failure of 5T Crane Unit (0707)**

On 20 July 2007 as part of standard maintenance procedures, a 3.9 Tonne three phase 3,300V AC electric motor was being removed from the Comer pulper. The task was being undertaken using a 5T Street Crane. As the operator used the raise control for the crane, the load dropped to the floor uncontrollably. The motor was written off due to the force of the impact. Fortunately no-one was injured. Upon investigation it was found that the fixing of the ring gear mounted within the wire rope drum had failed and the ring gear was able rotate freely within the rope drum. The crane manufacturers were contacted and they advised that Loctite 638 is used as the primary fixing mechanism between the push fit of the rope drum and the drive ring gear.

### **5) HSE Information/Campaigns**

CPI have informed Members of the following HSE Information/Campaigns

#### **Workplace Transport**

A media campaign will start in October and November and will focus on preventing people falling from vehicle. The campaign aims to raise awareness of the risk of falling that workers are exposed to when accessing and/or working at height on vehicles, and the actions that should be taken to minimise these risks.

**Workplace Transport Route map** including new management standards to be promoted nationally in December 2007

#### **Moving Goods Safely**

Inspection interventions November and December 2007 and March 2008 (but the paper industry is not specifically targeted)

**European Week for Safety and Health 22nd – 26th October** - This year's campaign slogan is 'Lighten the Load', and is dedicated to musculoskeletal disorders (MSDs).
