Just to expand a little further on timelines - it's likely that once we receive the documentation our internal consideration will take a day or two and consultation with the ECP will take at least a week (the competition law question is an unforeseeable wildcard at this stage. Hopefully it's nothing but if it's complicated it could also add weeks). Given that the next ECP meeting is on the 20th May I think we're now reaching the point where it would make more sense to formally present the applications at that meeting. It would ensure that a conclusion be reached on the day and also ensures that ECP members have the time available to consider the issue.

It may be that the ECP will endorse the applications as presented but by taking it to the physical meeting it would also mean that if you wished you (NFU, Bayer & Syngenta) could send someone along to the meeting to assist with any questions on the case for need and/or stewardship scheme etc. I believe this meeting will also be considering your application for 'Lumiposa'. As I say – there may be no questions but if you think it would be useful to attend please let me know details of those who would be best placed & able to attend and I can let the organisers know. Would you be happy to discuss this with Bayer / Syngenta?

Note that the latest date we can submit documents for that meeting would be Tuesday 12th May. We would need to have considered the submission in advance of then so realistically we'd want to see the documents by first thing Monday morning. All being well this would give us an outcome that we can be sending to ministers perhaps by the end of that week but more likely w/c 25th May (another bank holiday). It puts us closer to late June for any realistic authorisation but I think we're already looking at that sort of date as it stands.
