APPLICATION FOR NUCLEAR SITE LICENCES FOR BNFL/MAGNOX INTEGRATION

In accordance with Section 3(3) of the Nuclear Installations Act 1965 (as amended), the Health and Safety Executive hereby directs you to serve on the bodies described in the attached Schedule, notice that British Nuclear Fuels plc has applied for a nuclear site licence in respect of Berkeley and Berkeley Centre.

Further, the Health and Safety Executive specifies that each notice should give the following particulars:

1. the location of the site, its boundary and map reference;
2. the proposed use of the site giving a brief description of the purpose of the installation;
3. an explanation as to why the company is seeking a nuclear site licence and outline any changes to existing activities;
4. a statement of procedures to ensure the safe disposal of liquid, gaseous and solid effluents and wastes, including expected quantities;
5. a statement of your plans for dealing with emergencies associated with activities on the licensed site and the associated liaison arrangements, noting that the emergency plan will be submitted to the Health and Safety Executive for approval;
6. a statement about the proposed local community liaison arrangements; and
7. the enclosed standard licence conditions with an explanation that HSE currently propose (subject to comments received from respondents to this notification) that these will be the conditions attached to a licence, if granted.

The above is not necessarily a complete list of items and you may wish to include other information in your notices.

You should also inform the bodies upon whom notice is served that representations with respect to issues arising from their statutory duties may be made to [REDACTED] Health and Safety Executive, Nuclear Site Licensing Section, Nuclear Safety Directorate, St Peter's House, Balliol Road, Bootle, Merseyside, L20 3LZ, within three months of the date of the service of that notice.

Please request respondees to confine their comments to matters relating to their statutory duties and separate from those in response to any other application. They should be advised that if they wish to comment to HSE on any other matter they may do so in a separate letter.

Please ensure that copies of your notices are supplied to the Health and Safety Executive.
